Junior High Athletic Director Tim Fairchild mentioned that we hosted our First Sectional Track Meet.

Kelly Throneburg said they have had a lot of sickness in Prekindergarten – Grades 3 lately.

Curriculum Director Nicole Rummel reviewed the Schoolwide Title I Plan.

The Board discussed the Schoolwide Title I Plan for 2017-2018. Since the percentage has dropped from 40% to 20%, this will allow us to use the funds for larger items like textbooks, etc.

In reviewing Book/Other Fees for 2017-2018, Mr. Lindy recommended no change and that we keep them the same as last year.

Mr. Lindy suggested a 36-month term on the gas proposal/contract and locking in up to 50% fixed.

On the electric proposal/contract, Mr. Lindy recommended a 36-month term with a percentage locked in, but avoiding tariffs.
