Tim Fairchild updated the Board on the holiday service project they had at Centennial School with Meghan Ummel's parents in order to benefit the children at St. Jude's.

Director of Instruction Amber Buss said the Title Grants have been approved.

Superintendent Brian Kurz told the Board we had IDOT drop by for an unannounced inspection of our fleet. Carrie Woggon had everything in good shape.

Jeremy Faulk, Ed Faulk, Brian Kurz, and various teachers met with our insurance provider.

The EPG HS Course/Curriculum revisions for Science include a dual credit Forensics class and joining plant/animal science class together.

The IMRF Early Retirement Incentive gives employees an option to apply for five years which the Board would then match. There are ten employees who qualify.
